#### ARCHITECTURAL REVIEW COMMITTEE (ARC) NEWS

The ARC committee members are Essie McGhee-Chairperson, Cabott Stough and Braxton Bridgers. The ARC will continue to work tirelessly with the Towne Lake Home Owners to keep the neighborhood beautiful and reflecting high class.

According to Towne Lake Homeowners Covenants and ARC guidelines, homeowners must get ARC approval before making any modifications or repairs outside the home. **Repairs such as replacing windows, removing trees, repainting, adding a French drain, pergolas, room addition, etc. must have ARC approval prior to beginning work on the project**. However, we continue to have homeowners do work outside the home without prior ARC approval which clearly is a violation as outlined in the Covenants and ARC guidelines. Homeowners may be fined for starting outside modification on their home without prior ARC approval because it is a violation of the Covenants.

There is no fee for an ARC request but there will be a fine for starting a project outside the home without ARC approval. The average turnaround on an ARC request is roughly 24 hours, and most are approved with little or no questions asked. The ARC request form is available on our website but you may also send us an email at arc@townelakemontgomery.com.

Our goal is to keep the Towne Lake Neighborhood beautiful & attractive. We need everyone's help to achieve our goal.

#### STREETS, SIDEWALKS, and TRASH COLLECTION

Towne Lake has needed only a few minor repairs to our streets and sidewalks over the past year. Please continue to report problems with streets and sidewalks to the City of Montgomery Maintenance Department. Street/sidewalk maintenance can be requested by calling 311 or 334-240-INFO (4636). Hours of operation are Monday through Friday, 6:00 am to 3:30 pm. You may also e-mail your request to <u>311@montgomeryal.gov</u>.
